



Factsheet 5: Child-Related Work and Exemptions



What is child-related work?

Under section 6 of the *Working with Children (Criminal Record Checking) Act 2004*:

work is child-related work if the **usual duties** of the work involve, or are likely to involve, **contact** with a child in connection with any of the categories listed below,

UNLESS one of the exemptions listed here or in the category table below applies.

Exemptions which apply in all categories:

Child volunteers

- Work carried out on a voluntary or unpaid basis by a child (i.e. volunteer or student on unpaid placement under 18 years of age).

Employers / workplace supervisors of children

- Employers of children, or if you have fellow workers who are children (unless you otherwise carry out child-related work).
- Supervisors of volunteers who are children (unless you otherwise carry out child-related work).

Short-term visitors to Western Australia

- Work carried out by visitors to Western Australia, where the person is not ordinarily resident in Western Australia.
- The exemption only applies during the two week period after the person arrives in Western Australia and cannot exceed two weeks in any 12 month period.

2. A community kindergarten registered under Part 5 of the <i>School Education Act 1999</i>	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child who is enrolled at the kindergarten. 	<ul style="list-style-type: none"> ▪ No other exemptions apply.
3. An educational institution for children	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child who is enrolled at the educational institution. 	<ul style="list-style-type: none"> ▪ Police officers performing functions as a member of the WA Police. ▪ Universities established under a written law are excluded from the definition of educational institution for children.
4. A coaching or private tuition service of any kind	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child to whom the service is being provided in connection with an activity in which the child is participating, or ordinarily participates. ▪ When the coaching or private tuition is also in connection with a category xii) club, association or movement, the following broader exemption applies. Parent volunteers are exempt whose child is involved or ordinarily involved in at least some of the 'club' activities. 	<ul style="list-style-type: none"> ▪ An informal arrangement entered into for private or domestic purposes. ▪ Police officers performing functions as a member of the WA Police. ▪ Coaching or private tuition provided to a class of two or more students, that is not provided primarily for children.
5. An arrangement for the accommodation or care of children, whether in a residential facility or private residence	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child in connection with an activity in which the child is participating, or ordinarily participates. 	<ul style="list-style-type: none"> ▪ An informal arrangement made by a parent of the child concerned. ▪ Police officers performing functions as a member of the WA Police. ▪ Accommodation or care provided by a relative of the child. ▪ Arrangements for accommodation or care of children in a residential facility connected to, or used predominantly by students of, a university or other institution of tertiary accommodation.

10. A counselling or other support service	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child to whom the service is being provided in connection with an activity in which the child is participating, or ordinarily participates. 	<ul style="list-style-type: none"> ▪ Police officers performing functions as a member of the WA Police.
11. Religious organisation	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child in connection with an activity in which the child is participating, or ordinarily participates. 	<ul style="list-style-type: none"> ▪ No other exemptions apply.
12. A club, association or movement (including of a cultural, recreational or sporting nature and whether incorporated or not) with a significant membership or involvement of children	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child who is involved, or is ordinarily involved in some, or all, of the activities of the club, association or movement. 	<ul style="list-style-type: none"> ▪ An informal arrangement entered into for private or domestic purposes. ▪ Police officers performing functions as a member of the WA Police.
13. A ward of a public or private hospital in which children are ordinarily patients	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child in connection with an activity in which the child is participating, or ordinarily participates. 	<ul style="list-style-type: none"> ▪ No other exemptions apply.

14. A baby sitting or child minding service	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child in connection with an activity in which the child is participating, or ordinarily participates. 	<ul style="list-style-type: none"> ▪ An informal arrangement entered into for private or domestic purposes.
15. An overnight camp, regardless of the type of accommodation or how many children are involved	<ul style="list-style-type: none"> ▪ No parent exemption. 	<ul style="list-style-type: none"> ▪ Police officers performing functions as a member of the WA Police.
16. A transport service specifically for children	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child who is a passenger on the transport service, or is ordinarily a passenger on the transport service. 	<ul style="list-style-type: none"> ▪ No other exemptions apply.
17. A school crossing service, being a service provided to assist children to cross roads on their way to or from school	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child who is enrolled at the school. 	<ul style="list-style-type: none"> ▪ Police officers performing functions as a member of the WA Police.
18. A children's entertainment or party service	<ul style="list-style-type: none"> ▪ Work carried out on a voluntary basis by a parent of a child in connection with an activity in which the child is participating or ordinarily participates 	<ul style="list-style-type: none"> ▪ Performances open to the general public, not involving physical contact with children, whether on payment of a fee or otherwise. ▪ Where the service only involves the provision of equipment, food or a venue, and no other children's entertainment or party service. ▪ Police officers performing functions as a member of the WA Police.
